NOTICE: A non-refundable \$250.00 fee must accompany this application. If the application is approved you are requested to provide documentation of sales tax registration to the town within ten days of approval. Any applicant making any false statement in this application shall forfeit his permit and shall not be eligible to receive any permit for a period of ten years.

A privilege tax of \$100.00 is imposed on the business of selling, distributing, storing or manufacturing beer in this state effective January 1, 1994 and each successive January 1. Any holder of a beer permit issued after January 1, shall pay a pro rata portion of this annual tax when the permit is issued.
